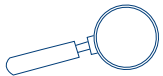

After initial evaluation:



1. Download and submit completed application materials; Self-Assessment, Certification Agreement, Payment and copy of software version to be certified.

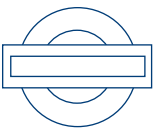

2. TRUSTe conducts a review of all disclosures, reviews application behavior against requirements and issues a findings report.



3. Implement changes and resubmit to TRUSTe for review.



4. TRUSTe will issue a pass/fail notice. Certified applications are placed on the whitelist and eligible applications receive the TRUSTe TDP Seal to place at the point of download.



5. The monitoring phase for program compliance begins.
